In this agreement you must utilize the branded water and our custom branded sauces.**

According to our calculations a Worx Café can turn upwards of R100 000 a month

Example Calculation:

Calculation made on a site where u have 750 customers per month and every customer buys 1 cooldrink or coffee and 1 hotdog or steak roll.

(An average car wash has 1000 + cars a month)

750 customers @ 30 days = 25 Customers per day.

Selling a 500mL Cooldrink @ R16.50 (Cost = R10) profit = R 6.50 per unit

Coffee @ R25 a cup (Cost R 10) Profit = R 15 a cup

Hot dog @ R45 (Cost = R20) profit = R25 per unit

Steak Roll @ R65 (Cost = R25) profit = R 40 Per unit

750 cooldrinks x R 16.50 = R 12 375 – EXP R 7500 = R 4875 profit

750 Coffee x R 25 a cup = R 18 750 – Exp = R 7500 = R 11 250 Profit

750 hotdogs x R 45 = R 33 750 – Exp R 15 000 = R 18750 Profit

750 Steak Roll x R 65 = R 48 750 -Exp = R 18750 = R 30 000 Profit

Therefore, u would have a Turnover of R 113 625 Expenses of R 48 750 And a Gross of R 64 875

Additional expenses such as:

Worker R 6500 a month

Gas R 350 a month

Sauces R 1000 a month

Polystyrene and Servettes R2000 a month

Mussitations R 3000 a month

TOTAL additional exp = R 12850 – R 64 875 = R 52 025 Net Profit per month
